1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

During its journey of over 50 years, the college has made tremendous progress on all fronts, be in education, sports, extracurricular besides a variety of other fields. The college has strength of 1500 students enrolled in the session 2022-2023. Situated near Haily Mandi, the college has its own campus in the district of Gurugram. The college is included under section 2(f) and 12(B) of UGC Act 1956. The college has lush green ground, library, well-equipped Science Labs, Computer Labs, ICT classrooms and a spacious Multipurposehall. The enriching study environment and the participative work culture govern the functioning of the college. The college administration and staff are committed to their work in order to meet the demands of changing educational requirements. The institution emphasises on the all-round development of the students' personality so that they can meet the challenges of life with grit and confidence. The holistic development of students is the main motto of the institution and it is making all efforts to meet this aim. Starting with the minimum requirements, the college has progressed by leaps and bounds and has undergone a complete transformation. 1. Covid-19 pandemic has given the college an opportunity to strengthen the usage of ICT in teaching and learning.

2. Alumni association needs to be more functional to provide the students with opportunities to learn from the alumni of the college.

- 3. With the availability of ICT-enabled classrooms and conference hall, job-oriented courses can be introduced.
- 4. Career counselling may be strengthened by keeping the students constantly in touch with their mentors.

Institutional Challenge

- 1. The progression of students in higher education is a challenge due to familial and financial circumstances of rural students.
- 2. The complete data of the progression of the pass out students is extremely difficult to compile as all the

alumni are not in touch with the college.

- 3. Communication skills, particularly in English, is a challenge due to the rural background of students and lack of awareness.
- 4. Collaboration with external agencies is a challenge.
- 5. The deputation of the staff in administrative and non-academic activities like pandemic duties, making of voter IDs, driving licences, and passports, etc. is a hurdle and it hampers the teaching-learning routine.
- 6. The chances of campus placements are few as the college does not have direct contact with the MNCs for substantial MoUs.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Curriculum is the essential aspect of any education system. All other aspects whether teaching, learning, evaluation, research and development, infrastructure, learning resources, student activities and support system revolve around it. Therefore, curricular aspects and the best practices connected to curriculum design and development play a very significant role in the quality of higher education since the curriculum has a decisive role in steering the other elements of quality. The institution follows curriculum designed by the affiliating university i.e. Gurugram University, Gurugram. The college follows the academic calendar provided by the university and all the faculty members prepare their monthly lesson plans to complete the syllabi in time. Class tests, quizzes, seminars are conducted in each semester for evaluation. Two assignments per subject need to be submitted by every student in each of the semesters. Internal assessment is prepared according to the university norms and is uploaded digitally on the portal of the university. Practical examinations are conducted according to the examination schedule provided by the university. Evaluations of practical as well as theory examinations are conducted in time. The institution has well planned curriculum delivery and documentation system in place.

Faculty members use the reference books and provide notes to the students. The teachers organize quizzes so that students can be motivated to prepare for competitive exams. Group discussions, questionnaires, classroom seminars are also organized for better understanding of the topics and to overcome the hesitation. To make teaching more effective, they use the ICT assisted methods like online lectures through Google classroom, Google meet, Power point presentation, YouTube lectures and many more online platforms. CBCS has been implemented in Postgraduate course since 2018. To enhance the professional and field skills of the students, extension lectures have been organized by inviting experts from various industries, institutions and IT fields. Feedback is taken from all stakeholders and consequent action is taken after carefully analyzing the feedback.

Teaching-learning and Evaluation

The College provides an inclusive and equitable working environment which creates conditions for all round development of students coming from diverse fields. The admission process is highly transparent, well-administered and follows university guidelines concerning admission in various categories. The admission committee also counsels the students at entry level and makes them more aware about subject and its future prospects. The college conducts orientation programme for new students and appraises them about courses, objectives, vision-mission of the college, infrastructural and other facilities and tentative schedule of curricular/co-curricular/extra-curricular activities of the year. The ratio of the students and full-time teachers in college is remarkably good. College has a systemic mechanism for regular assessment and evaluation of

students. Advanced and Slow learners are identified through internal evaluation mechanisms like class tests, assignments, group discussions among others. Remedial and extra classes are conducted for slow learners. For enhancing learning experiences teachers adopt many methods i.e., lecture method, computer-assisted method, experiment method, etc. Recently, due to COVID-19, teachers had to explore many online methods for making learning more effective. Majority of classrooms and labs are ICT enabled which provide teachers and students more resources for effective teaching and learning process. In addition, the college staff members strictly follow the mentor group system. Every year students are allotted to the mentors so that they can inspire the students for their bright career. POs and COs for all programmes are stated and communicated to teachers in departmental meetings and students through orientation programme and uploading it on College Website. Different tools such as attendance, assignments, unit tests, quizzes, presentations etc. are used for the evaluation of these outcomes. The college ensures complete transparency in internal assessment according to the instructions issued by the affiliated university. Grievances related to internal assessment are addressed by internal assessment committee and grievances related to university examination are forwarded to affiliating University where they are addressed in time bound manner. Majority of the students, admitted in college, belong to rural areas, backward communities and economically weaker sections of the societies, yet results are satisfactory.

Research, Innovations and Extension

The institution is continuously working in this regard. Two national seminars have been organized where faculties from various institutions participated and shared knowledge. Panel discussions and extension lectures are organized in the college at regular intervals. Further, 44 research papers of the faculty members have been published in various national and international journals. Among them, 09 research papers have been published in journals listed in UGC CARE list and Scopus, while other research papers are published in recognized indexed journals. The faculty of the college has written 24 chapters in books published by reputed companies. Different extension activities have been conducted by various committees of the college such as NSS, Women Cell, Red cross, Cultural Committee and other academic departments of the college. The NSS units of the college have adopted some nearby villages. NSS organizes one-day and seven-day camps. Various activities like Nukkad Natak, rallies, cleanliness drives, extension lectures, rangoli making competition, speeches, debates, poster making, slogan writing etc. are organized. The topics of such activities are based on social issues like women empowerment, health and safety, traffic rules, legal literacy, energy, water, HIV AIDS, First Aid etc. The cultural committee organizes cultural events like Talent Hunts and annual function. The college also organizes an annual sports meet. Sports teams from various colleges participate in intra-college and intercollege events. Science exhibition is also organized in the college. Here, students take active participation in the events organized by the departments of Chemistry, Physics, Geography, Computer Science etc. Different academic departments organize departmental activities like GD, PPT making, Quizzes, Poster and Slogan making etc. Further, to ensure the holistic development of students, workshops and training sessions for selfdefense, Yoga, Cyber safety etc. are also organized. Students are made aware about their voting rights by activities of Voter ID Committee/Political science department.

Infrastructure and Learning Resources

Government College, Jatauli, Hailey Mandi takes immense pride in being one of the most beautiful campuses of Gurugram University affiliated colleges. It is one of the biggest rural affiliated colleges of the University. The endeavour of the college is to proffer a conducive environment for the students to foster their personality that is anchored in the traditional Indian values. The college is built with an imposing infrastructure, which includes a well-stocked and well-furnished central library with ILMS, SOUL software. College campus has three main blocks having thirty-five fully ventilated classrooms, admin office, storerooms, washrooms. The campus is furnished with computer laboratories and science laboratories to conduct practical with latest equipment. It is also endowed with various sports facilities such as a large sports field, running track, volleyball ground, kabaddi, cricket kit, chess, table tennis, javelin and hammer throw, batons for relay race and yoga mats and a gym hall. The campus is equipped with ICT enabled rooms that are imperative for a holistic growth and development of the student community. Smart classrooms, digital lounge, English language lab, projector enabled classrooms help teachers to make teaching more effective and student centred. The campus features a state-of-the-art multipurpose hall, seminar room as well as a huge open air-theatre for the overall growth of the students. It also has a Placement Cell for providing career opportunities to the graduating students in the top organizations through campus recruitments and job fair. College has a unit of NSS and NCC each to help students develop their personality through community service and bring out best out of them. Women cell and girl's common room are also established in the college to empower and help girls to attain their own stand in a competing world. Lawns and botanical garden are well maintained. Canteen and parking facilities are also available in the campus. CCTV cameras are installed in each and every corner of the college to ensure the safety of the students. The whole infrastructure is maintained and constituted by the funds and grants provided by Haryana State Government.

Student Support and Progression

Student Support and Progression of the College depends totally upon the students' performance, progression and gainful employment. The College has well-structured and well-organized guidance as well as counseling system benefitted through scholarships, free ships and other means. During the last five years, more than thousand students were benefited by the different government schemes like SC Stipend, Post Matric Scholarship for BC Category, Fresh Award of Haryana State Merit Scholarship, Meritorious Incentive Scheme, Merit Scholarship, and Earn While You Learn. The large number of students is enrolled in capability enhancement schemes such as Soft Skills, Placement & Career Cancelling Cell etc. The institution has constituted committee to deal and resolve sexual harassment cases. No complaints regarding sexual harassment have been filed during the last five years. Students' progression to higher studies and their placement was a challenging issue before the Institution. In the last five years, about 170 students from our college have been employed or have gone to higher education. Besides, students have qualified in State, National level examinations such as NET, CTET etc. Moreover, the Institution has adequate Sports infrastructure that promotes active participation of students in various tournaments. The Institution also encourages to the students to participate in cultural activities at the University level 'Youth Festivals' and other Cultural activities. The alumni also provide support to the Institution for the student support and progression. Till now the alumni association is not registered in our college, however, we are trying to get it registered soon.

Governance, Leadership and Management

Any educational institute advances on account of its efficient faculty members, diligent students, supportive administrative staff and a dynamic Principal. Since the inception, the gamut of the college is to achieve excellence in all spheres so that the students and faculty of the college gets high class infrastructure and opportunity to learn new skills to deal with universal challenges. To make this effectively possible, the college has sprawling campus, well maintained computer laboratories, sports ground, gym-hall, classrooms, well stacked library etc. The Placement Cell, NSS, NCC and Women Cell, and other committees' function for the overall wellbeing of the students. Initially, the college was known as Kamla Nehra College, later on, after the

takeover by Govt. of Haryana in the year 1980, the name of the college was re-coined and it came to be known as Govt. College Jatauli, Haily Mandi. The College has a democratic set up where each unit is given full freedom to work out its innovative plans for development. Internal coordination and harmony among the various units of the college is given utmost priority. After the introduction of Performance Appraisal System (PAS) by Haryana Govt. for teaching and non-teaching staff in the Govt. colleges and universities as per UGC guidelines, all the faculty members fill prescribed Performa for self-appraisal. It encourages the faculty members to ensure excellent performance in teaching-learning and research. The College has a proper system for effective and optimal use of available financial resources. External financial audit was done in the year 2018 as per the government rules. For the robust and transparent functioning in college, Internal Quality Assurance Cell (IQAC) is well established. In its pursuit of excellence, it reviews the teaching learning process, structure and methodologies of working, student results at periodic intervals through various committees like academic committee, internal assessment committee etc. IQAC also ensures the coordination in academic, administrative, financial and other activities in the institution.

Institutional Values and Best Practices

This institution organizes various gender equity promotion programs. It adopts environment friendly practices and takes necessary action such as energy conservation, green practices, safety and security, career counseling, waste management, institutional values and social responsibilities etc. When the fresher students come to college, they are so anxious for their safety. This is the major aspect of every college that they ensure the safety and security for every student. All of our staff is committed to ensure the safety of the students. Anti - ragging cell provides safety in the campus so that the fresher student feels safe from the senior students. In the college campus, there is a completely separate common room for the girl students. There is proper waste management of almost all kinds of waste like solid, liquid or E-waste etc. Institute has one rain water harvesting system and solar energy panel. Women cell, Placement cell and NSS play an important role for inculcating moral and social value. The programs are designed for the students for their constitutional rights, gender sensitivity, career opportunity, safety and discipline. Mentor classes are held in a month in which the mentor enquires about any problems in the college premises and also tries to give solutions to the students. Further, Innovative teaching methods in education encourages teachers and students to explore research and use all the tools to uncover something new. It involves a different way of looking at problems and solving them. The distinctiveness of the institution is the all-round development of students. The institution organizes all socio-cultural functions of personality development like (Quiz, debate, declamation). Discipline is the key factor in any institute, so all the staff members play an active role to furnish the task by doing proctorial duties in which they have a hawk eye at every corner of the college. Motivational lectures of eminent figures of various fields are arranged for all round development of the students and to make them responsible citizens following the national values of sociocommunal harmony and national integration.

Human Values and Professional Ethics:

In the subject of Sanskrit, education on moral values is given to the students through a number of stories and epics such as *Hitoupdesh* (B.A. I), stories from epics (B.Sc. II), *Shrimad Bhagwad Gita* (B. A. I). Through the medium of literature, an effort is made to

inculcate moral values in the students. Besides the examination point of view, the message of righteousness, truth and other values is given to the students on which they can build a healthy nation.

In B.Com. (6th Sem) a subject titled "Corporate Governance" covers various topics such as concept, principles, models, mechanisms of corporate governance; importance, initiatives and challenges of corporate governance and how such mechanisms ensure ethical conduct of business.

Philosophy is taught as an optional subject at the level of B.A. I, B.A.II and B.A.III classes.

In an educational institution, the importance of infrastructure and learning resources present therein cannot be gainsaid. For over more than four decades, Government College, Jatauli Haily, Mandi has striven to provide a range of facilities to support its students in their studies and give access to a wealth of materials, equipment and information. The College has in place a well-oiled system consisting of physical facilities, a smoothly functioning administrative set-up and excellent staff to cater to the needs of the student. The institution has adequate infrastructure and physical facilities for teaching, learning viz. classrooms, laboratories, computing equipment etc. The College has airy and high-ceilinged classrooms of varying sizes. Classrooms have LCD projection systems and some rooms also have a complete audio-visual capability. There are science laboratories with instruments and apparatus needed to conduct all practical exercises prescribed in the curriculum. The College encourages research, which they carry out in their own laboratories. Air-conditioned computer laboratories with all facilities to meet the requirements of students for blended learning. The computer labs have all latest software and internet connectivity. Additional resources such as printers, projectors, wireless internet connectivity for use in laptop are also provided by college. A Botanical Garden has a number of plants and fulfils the need for study of plants in their natural surroundings. The College has a fully automated library, having over thousands of books, some of them very rare. Some of the Departments also have their own collection of books curated to meet the growing demands of academia. Special care is taken to provide assistance and services to students with special needs. A number of common facilities like a seminar room, multipurpose hall, open air theatre space, etc. provide the much-needed space for the artistic expressions of the students. The administrative and accounts block house the machinery needed for the smooth functioning of the institution. There are rooms earmarked for units like the NCC, NSS, Placement Cell, Women Cell, Reading Room and others in the building of the College. The college also provides first aid facilites when needed. The college believes in the dictum of a healthy mind in a healthy body. It has a large sports complex which provides a volleyball ground, a running track and other required equipments like shot put, yoga mats, discuss, javelin, hammer, and batons. A gymnasium with treadmills/walkers, gym cycle, body solid leg press, and body solid chest press satisfy the needs of the health-conscious students and staff. A canteen and a fast-food kiosk provide reasonably priced and hygienic food, as well as the much-needed space for socializing and general relaxation. The college provides a spacious parking facility to students and staff members so that they can park their vehicles in the campus itself. The institution is under CCTV surveillance to ensure safety and security. To make the college future-ready, a number of infrastructural projects are in pipeline.

6.3 Faculty Empowerment Strategies

6.3.1

The institution has performance appraisal system, effective welfare measures for teaching and non-teaching staff and avenues for career development/progression

Response:

Haryana Govt. has introduced Performance Appraisal System (PAS) for teaching and non-teaching staff in the Govt. colleges and universities as per UGC guidelines. All faculty members fill prescribed Performa for self-appraisal. PAS system encourages the faculty members to ensure excellent performance in teaching-learning and research. The institution has performance based appraisal system for the assessment of teaching and non-teaching staff.

For Teaching Staff:

The API (Appraisal Performance Index) of the teaching staff is on the basis of their academic, research and their contribution to other extra-curricular activities. It is also based upon his/her relation with the students, colleagues and administration. The performance appraisal report is to be filled by the teaching staff in a given prescribed performa which includes three main categories i.e. Category one contains Teaching, Learning and Evaluation-related activities. Category two contains Co-curricular, Extension and Professional Development related activities. And Category three is mainly focused on Research and Academic contributions. The PAS performa is the primary means of assessing a faculty member for the purpose of promotion under Career Advancement Schemes (CAS) and awards. The Performance Appraisal Reports (PARs) provide good feedback to faculty. The overall report is further reviewed by the Principal and the IQAC.

Secondly, ACR (Annual Confidential Reports) are filed by each and every teaching staff. Annual Confidential Report (ACR) containing information relating to multiple activities such as subjects taught, workload, lectures delivered, teaching methods applied, participation in examination and evaluation activities, academic and professional growth, involvement in extracurricular activities and college administrative work, research work, etc. is filled by both teaching and non-teaching staff at the end of the session. After verification and feedback by the Principal, ACRs are forwarded to the Directorate of Higher Education, Panchkula. The entire process of filling up the ACRs is online.

Non-teaching staff:-

Every non-teaching staff member is assessed for his/her performance according to his/her works, duties and responsibilities assigned by the principal. The systematic procedure has helped the principal to motivate the employees for better performance.

6.4 Financial Management and Resource Mobilization

6.4.1

Response:

The College has a proper system for effective and optimal use of available financial resources. The key decisions related to finance and related matters are constantly monitored and the proper utilization of allocated funds is encouraged. As per The Higher Education Department of Haryana, funds are allocated in different stratas like EWYL, material and supply, lab up-gradation, sports grant, NSS Grant, Women cell and placement cell for optimum utilization. The procedure for purchasing materials involves survey of market, inviting quotations from different suppliers and comparing rates. Finally, the lowest possible rate with best quality material is selected. The mode of payment is done either by cheque or by internet banking. Under the scheme of 'Earn While You Learn' run by Haryana Govt., hard working meritorious and poor students are selected from various streams to provide their services in Labs, Library and office for which they are paid accordingly. Various labs like science, geography, computer science and English are upgraded every year with modern equipments. Under sports grant, sports equipments are purchased and annual athletic meet of college is also organized.

UGC has clearly mentioned for which purposes the grants are granted. The grants received from the state government are also under special heads and they are spent for the purposes they are meant. The institution has at its disposal the funds collected from the students. These funds are made use of for the various needs that come up from time to time. All the fees to be received from the students are clearly mentioned in the prospectus of Directorate of Higher Education Department, Haryana to different heads. The Principal, Bursar and the committees of the college monitor the use of resources received from the state government, UGC and fee from the students.

All the quality assurance measure, across academic planning and administrative area are governed, implemented and supervised by the IQAC. The institution reviews its teaching learning process, structure and methodologies of working and student results at periodic intervals through various committees like academic committee, internal assessment committee. These committee monitor student's internal assessment and attendance periodically. Remedial classes are taken by respective teacher to bridge the gap between high performer and weaker students, where in students are tutored again to improve their performance in forth coming examination. Laboratories and practical classes are arranged up for student of science stream to achieve institutional goal.

In the pandemic era, the use of smart classes and modern technology eased the learning process for all students. Students are exposed to a new level of learning process. Smart classrooms include videos and presentations, which include visual and auditory stimulation for the students. The info-graphics, like pie charts, graphs as well as notes, are saved in the system. Thus, it saves a lot of time. Learning becomes a much easier process. Moreover, in EDUSAT room, special lecturers are conducted on various topics to help students to have better understanding of concepts. Students are encouraged to give PPTs so that topics can be easily understood by them. This latest technique helps students to adopt latest technology in their learning process

Teachers are required to prepare lesson plans and these are made available to the students before the commencement of the semester. Lesson plans ease the learning process for teachers as well as for students. IQAC monitors and reviews the learning process adopted by teachers. Daily monitoring of conduct of the classes is done by the principal.

Title of the practice - Health Awareness

Objectives of the Practice

To improve the quality of life through prevention and treatment of disease, including mental health. Promoting awareness of community health issues and preventive action is a vital part of our foundation mission. It aims to promote the well-being of the students and encourage healthy life styles. These programmes help students in solving their health using their potential and to establish proper health behaviour. The ultimate goal is to improve the health not only of the individual but for community also.

Context

The idea and concept of all these programmes is to make the people healthy and to create awareness about healthy life style which is the need of the hour. Certainly there are remarkable achievements in some dimensions of health as compared to the past. But the change of scenario is due to better living conditions and availability of some resources like safe drinking water, general awareness etc. But not due to change in human behaviour. So with this burning desire and motto "HEALTH FOR ALL" the college conducted different activities and programmes related to health issues every year. It is in this context that these awareness programmes are of great relevance.

The Practice

The college had conducted a number of health programmes in the last few years and is still on the same path :

Observance of "Voluntary Blood Donation Fortnight" from 1st -15th October 2019 in 249 Red Ribbon Clubs Haryana. Red Ribbon Club (RRC) along with Youth Red Cross Society (YRC) of Government College of JatauliHaily-Mandi, Gurugram with the help of Red Cross Society Gurugram, organized a blood donation camp in College premises on 12-10-2019 and collected 38 units of blood. On 10th October 2019 a Poster making event was organized to aware the students aboutHIV/AIDS and VBD and displayed the IEC material. A lecture is organized by health worker Smt.Anuradha in order to aware the students about HIV/AIDS. A 06 Days Yoga and Fitness workshop was also organised from 13 Dec to 18 Dec 2021 for the girl students under women cell. A fifteen days AIDS awareness camp was organised by Red Ribbon Club in the month of October,2021. The students were given the awareness, reason, preventive measures about this disease. Awareness Rally on No Tobacco Day was organised by N.C.C. and N.S.S students of college in November,2021. One 7-days awareness camp about drug addiction awareness was organised in March,2022 by N.S.S. The students got benefit of listening lectures from various experts in this field.

Title – Social Awareness

Objectives of the Practice: The objective of these programmes are to educate the students of their rights and duties, benefits and facilities available through various government agencies and how to obtain them e.g. opening a bank account, avail health insurance, get educational loans and use of RTI etc. These programmes create awareness by counselling youth to stop bad habits and by educating people on political reforms and how one should exercise his vote. One of the main objectives is also to inculcate the

ideas of respecting other rights to promote community luring and doing something for society.

Context

Social Awareness is defined as being aware of the problems that different societies and communities face on day to day basis and to be conscious of the difficulties and hardships of society strive to achieve this through interaction and education. The main stress is laid on to aware the students of their environment as well as being able to accurately interpret the emotions of people with whom they interact which will further help them in life. What we learn in our young life leaves on indelible impact on our lives. During this stage of our life, we form and reform views on the different aspects of life.

The Practice

On 11-08-2018, students of GC JatauliHailyMandi were given the knowledge of DURGA SHAKTI APP. This campaign was promoted to spread awareness about women safety. On 25-08-2018, all the females of GC JatauliHailyMandi marched a rally to show women empowerment.

On 01-09-2019, a camp was organized for legal awareness among public. The objective was to aware the students about their legal rights. On 29-09-2019, inter college state yoga tournament was organized. The objective was to spread the awareness about health through yoga.

On 25-01-2019, a seminar was organized on sexual harassment and awareness about that by women cell. The girl students were explained the details of sexual harassment and gave awareness about this that how they should protect themselves by their legal rights.

On 04-03-2019, a camp was organised to spread the awareness about cleanliness. Students from college participated in huge strength and made the campaign successful.

NSS SEVEN Days Special Camp was organized from 10-02-2020-16-02-2020. April 2020. The volunteers took part in many activities during COVID -19 helping the needy by providing them food, shelter, hand-made masks. June 21,2020 - International YOGA day: The volunteers took initiative to do yoga along with their families.

Anti-narcotics day, Doctor's day, Paper bag day, International Youth Day were celebrated by NSS unit.

An Extension lecture was organised by Women Cell as on 13th November, 2021. The topic was Women Entrepreneurs in India. An Extension Lecture was organised on 04th Dec, 2021. The topic of the lecture was Gender Sensitization: Issues and Challenges.

There is an online UPS 6KVA It has 21 revolving chairs that are very comfortable and for a long time students can sit on them.

This special grant to set up digital lounge is given to only few colleges in Haryana and G.C.Jatauli Haily Mandi is one of them. The students from any stream can use digital lounge for internet surfing, carrier exposure and utilize it fully for their education purposes. This Digital Lounge will prove a milestone for the students of our college since the students have very humble and rural background and such facility will really help them to technically acquaint. Information and Technology is going to prove a vital role in the educational institutions and such kinds of facility will definitely boost the level of the students who totally belongs form rural areas and it is beyond their reach to get such facilities on their own.
